Short Film Festival - Fifteenth Edition

Regulation

- ‡ **ART. 1** - The cultural Association **ARCHÈTIPO** and the **MARCO NOCENTINI'S FRIENDS**, together with the Assessorate to Culture of the town **Council of Bagno a Ripoli (Fi)**, is organizing the *14th* Edition of the Short Film Festival “**SCHERMI IRREGOLARI**”, which will be held at the **TEATRO COMUNALE OF ANTELLA**, via Montisoni 10, Bagno a Ripoli (Firenze) Saturday March 22, 2014 at 9.00 p.m.
- ‡ **ART. 2** - May participate to the festival 20 minutes length short films in DVD format. Any author may participate with more than one work as long as not having been shown in previous editions of the festival.
- ‡ **ART. 3** - The Festival includes one single section ,Fiction Shorts (animation, documentaries, art or musical video clips are excluded). Foreign shorts must be provided with Italian subtitling.
- ‡ **ART. 4** - Participation to the festival is free.
- ‡ **ART. 5** - The works presented will be examined by the artistic direction of the festival which will determine their admission to the festival.
- ‡ **ART. 6** - The works admitted to the competition will be viewed by a Jury of experts that will assign :

PREMIO “SCHERMI IRREGOLARI 2014” FOR BEST SHORT FILM : € 500
PREMIO “MARCO NOCENTINI” FOR BEST EDITING : € 500

- ‡ **ART. 7** - The works presented will be used for projection and will not be given back. The shorts should be sent in DVD format (1 DVD for each work), together with the inscription duly compiled (anything not such will lead to the exclusion from the competition). Shorts must be sent within **JANUARY 31, 2014** to :

- ‡ **ART. 8** - The organization of the Festival, even though using the utmost precautions, is in no way responsible for damage ,loss or theft of the works.
- ‡ **ART. 9** - The authors participating to the competition authorize the office of the festival to use the works or part of them for non remunerative promotional reasons on television programs through a release attached to the inscription.
- ‡ **ART. 10** - In order to participate to the competition, the regulations must be entirely accepted. The organizing comity reserves itself the right to modify the present regulation in case of force majeure. The management of the festival will deliberate in any case of controversy or in any matter not included in this regulation.
- ‡ **ART. 11** - The award for best short film will be given to the director of the winning short (Best short film), the award for best editing will be given to the editor of the winning short (Best editing). If either finalist should not be attending the awards, a hand written delegation (complete of all personal data and signed) should be presented to the festival organization before the beginning of the ceremony which authorizes a given person to receive the award in their place. If either the winner or delegate should not be present, the management of the festival will send, via postal service, the award to the winner, prior telephone agreement.
- ‡ The Organization declines any responsibility for the missing receiving of the award.
- ‡ The Jury grants itself the faculty to not assign the awards to the shorts that do not fill in the quality standards required.
